URGENT PUBLIC ALERT:

WITHDRAW OF ANACONDA SEX BOOSTER COFFEE DISTRIBUTED BY MDI DISTRIBUTORS

FOR IMMEDIATE RELEASE – The Zambia Medicines Regulatory Authority (ZAMRA) is a statutory body established under an Act of Parliament, the Medicines and Allied Substances Act No. 3 of 2013 of the Laws of Zambia. The main mandate of ZAMRA is to ensure the quality, safety and efficacy of medicines and allied substances for human and animal health protection.

On this background, the Authority wishes to notify the general public that following laboratory analysis of Anaconda Sex Booster Coffee, the product was found to contain undeclared Sildenafil Citrate, a Prescription Only Medication. Anaconda Sex Booster Coffee is labelled to contain only herbal ingredients and claims to have no side effects.

Sildenafil Citrate is a Phosphodiesterase type-5 inhibitor that is used primarily for the treatment of erectile dysfunction in men, on prescription by qualified medical personnel. Adulteration of a product with sildenafil may pose serious public health risks to unsuspecting consumers, especially those with pre-existing conditions for which sildenafil may be contraindicated. This may lead to severe adverse drug reactions, including heart problems, heart attack and even death.




